







# Caveat 声明

- The Government recommends, subject to approval by the Governor-General, that the changes outlined in this presentation would take effect on 19 November 2016.

# Key changes 主要变更

The framework is intended to make the process of applying, or sponsoring an applicant, simpler. 此框架旨在简化申请人或申请担保人评审流程

- Reduced number of subclasses from seven to four. 缩减类别，由7种类别到4种类别
- 100% online lodgment for all subclasses 所有类别100%在线申请
  - except subclass 403 (International Relations) which will retain a paper lodgment option. 403类别（国际关系）将保留纸质申请递交程序。
- Removal of sponsorship and nomination requirements for specific short stay activities 对特殊短期停留活动免除担保和提名要求
  - A single ‘Temporary Activities Sponsor’ class valid for five years, replacing six sponsor classes. 拥有五年有效期的单一“临时活动担保”类别替代六种担保类别
- New Visa Application Charge (VAC) pricing structure: 最新签证申请费定价体系
  - VAC will be aligned across the four visas 4类签证申请费保持一致


# Visa Framework 签证框架

There would be four visas under the new framework:

- Temporary Work (Short Stay Specialist) (Subclass 400)
- Temporary Work (International Relations) (Subclass 403)
- Training visa (Subclass 407)
- Temporary Activity (Subclass 408)

Five visas will be repealed:

- Temporary Work (Long Stay Activity) (Subclass 401)
- Temporary Work (Training and Research) (Subclass 402)
- Special Program (Subclass 416)
- Temporary Work (Entertainment) (Subclass 420)
- Superyacht Crew (Subclass 488)



# Temporary Work (Short Stay Specialist) (Subclass 400) visa 临时工作签证（短期停留专家）400类别

# Temporary Activity (Subclass 408) visa

# Training (Subclass 407) visa 培训类签证（407类别）

For people who want to come to Australia on temporary basis to undertake occupational training or participate in classroom based professional development activities.



# International Relations (Subclass 403) visa 国际关系类签证（403类别）

The settings for this visa have not changed, except the addition of the Seasonal Worker Programme. The visa allows for both online and paper applications, and is for people who want to come to Australia on a temporary basis:

- In relation to a bilateral agreement
- To represent a foreign government or teach a foreign language in an Australian school
- To undertake full-time domestic work for a diplomat
- As a person with statutory privileges and immunities
- To participate in the Seasonal Worker Programme for which the lead agency is Department of Employment.
